- Letter of endorsement by nominator demonstrating the contributions individual has made in the area of occupational health, safety and wellness and the impact this nurse has had on her organization
- Licenses RN/LPN in the state of Ohio
- Has demonstrated service to her community
- Nominee’s resume (3 page maximum): Outlining credentials, educational background, work experience, professional activities, presentations or projects
